ANNUAL REPORT 1942.

During the year, there have been three trainees in residence, Misses Davidson, Wilson and Hilder. Lectures have been regularly given by Revs. Drake, Fowles, Williams and Hailwood, while Miss Tahiwi has continued lessons in Maori. We expect three other students next year, and Misses Davidson and Wilson will commence work under the Home Mission Board.

Most of the Deaconesses have sent in encouraging reports on their work. Almost all these have been amongst the Maori people. During recent weeks, Sister Edith has married and her connection

with the work has now been severed.

The Committee has had a difficult year owing to staffing problems and the rising cost of living. We shall ask Conference to give a decision on the wisdom of continuing the work as at present. There are twenty-two College students in residence at present.

Owing to ill-health, Sister Ruth Fawcett resigned after a year of valuable work. The Committee has been fortunate in securing the

help of Miss Purdie of Dunedin as Matron.

The following grants are recommended for next year:—Fire Insurance Fund, £125; Foreign Mission Fund, £25; Home Mission Fund, £100; Contingent Fund, £100.

In spite of difficulties regarding paper supplies and also shortage of labour our printers have continued to serve the Committee with much acceptance. The paper continues to enjoy the warm appreciation of the Church, and its circulation continues slowly to increase. The Rev. H. E. Bellhouse, as Editor, holds the confidence of the Connexion, and the Rev. G. R. Harris maintains his high standard of service as Associate Editor. Both are cordially nominated for reappointment. To our circuit agents the Committee of Management tenders cordial thanks for their continued co-operation. The Committee has done all that was possible to give effect to the resolutions of last Conference.

The position of the funds is shown in the financial statements. In view of the continued uncertainty in relation to all publishing matters the Committee asks for a grant of £150 from the Connexional Fire Insurance Fund and for £100 from the Contingent Fund, in addition to the standing provision of one-half of the honoraria for the Editors and their contingent expenses.
