Church Life Survey

"As a former convener of the Church Life Survey in New Zealand (Professor Peter Lineham is the current secretary of the committee) I would like to strongly encourage all our parishes to take up the opportunity to share in the 2023 survey.

The survey will provide presbyters and local church leaders with a picture of the life of their congregation including the following:

- 1. What people most value in this congregation.
- 2. The strength of attenders sense of belonging to this congregation.
- 3. Whether people feel a sense of God's presence in worship.
- 4. Whether people are being challenged to take action (ie. living out their faith)
- 5. How satisfied attenders are with what the church offers for children, youth and young adults.
- 6. Whether people feel they are growing in their faith
- 7. Whether they are willing to share their faith
- 8. Whether they see their church as inclusive of different kinds of people
- 9. Whether they believe that Christians should actively care for the environment
- 10. Whether they think their church has a vision and sets goals for the future

The above is a brief sample of the questions asked. The collated and anonymous answers which the Church Life Survey team will provide to each participating congregation will give **a snapshot that can help the leaders shape the future direction of the congregation.** The survey results can also provide important information for parishes and Synods with regard to stationing.

This year the survey can be filled in on people's smart phones, tablets, computers. Paper copies of the survey form can also be run off in local church offices and made available for those who prefer paper and pen. The survey form has also been translated and will be available in Maori, Samoan, Tongan, Korean, and some other languages.

It is great that the Connexion is willing to pay for your congregations participation. The Methodist Church's "Group Code" is 111885. The full instructions for participation were sent out by email on the 22nd May from the Connexional Office to all parishes.

BwoFs – Building Warrants of Fitness

Work has begun on checking the status of our building warrants of fitness.

Let me first try and explain what a BWoF is.

"A building warrant of fitness (BWoF) is a building owner's annual statement confirming the specified systems in the

compliance schedule for their building have been maintained and checked for the previous 12 months, in accordance with the compliance schedule."

Ministry of Business, Innovation & Employment - Guides for building officials

A compliance schedule of specified systems includes (but is not limited to) things like sprinkler systems, fire alarms, security doors, fire doors, exit signs, and heat detectors.

Buildings likely to have specified systems will be churches, halls, hospitals, offices and boarding houses. Buildings with a number of specified systems often fit the criteria – such as those with fire alarms, emergency power systems, sprinkler systems, passenger-carrying lifts, automatic sliding doors, mechanical ventilation, and air conditioning systems.

The compliance schedule will also outline the frequency of checks that must be carried out each year and who should do the checking. Some items can be checked off by the building stewards, but other items will require specialists to do the checking – Independent Qualified People (IQPs). All councils provide a list of IQPs that operate in their region – check out your <u>council's website</u>.

The councils and I have checked our systems, and two out-of-date BWoFs have been discovered so far, but we still have Auckland to check, where most of our buildings are.

Of the two out-of-date one of them didn't pass inspection as a new IQP interpreted the rules differently than the previous IQP. This led to the council coming to audit the building and overturning the new IQP interpretation. The new BWoF has been issued.

The second BWoF has just been neglected and the building steward has been informed to bring it up to date. In the meantime, the council will be booking an appointment to audit the building.

My queries have also prompted one council to arrange an audit of non-BWoF buildings. This means that they may request passive options be installed in the buildings such as exit signs and clearways of final exit points.

Remember too, that the Insurance Fund provides a subsidy for the installation of a monitored alarm system of \$2,000 or 80% of the cost, whichever is the lesser amount. These systems may be incorporated with items from the compliance schedule.

While I apologise for stirring up the councils to look at our buildings, I am not sorry if our buildings become safer.



Methodist Mission Southern: Support Networks & Community

"And though a man might prevail against one who is alone, two will withstand him—a threefold cord is not quickly broken." Ecclesiastes 4:12

We celebrated the Methodist Mission Southern's 133rd birthday with a joyful gathering of kai and kōrero. Coming together we were reminded of how our interconnectedness creates our community. We received tiny Kahikatea tree seeds to plant, and the analogy of how this specific tree's roots grow wide, not deep, and that they intertwine with each other to support the enormous height of each individual tree (New Zealand's tallest indigenous tree) whilst creating a community with connected strength at the roots. Planting tree seeds is certainly faith in the future.

The Reverend Donald Phillipps describes MMS's beginnings "By the 1880's in England many of the denominations had become

deeply concerned about the plight of the urban poor, in particular. The title of a book written at that time – The Bitter Cry of Outcast London - encapsulates the acute sense of responsibility that many Christians felt. Urban missions in the main cities of England were established, and this example was followed in Australia, and then in New Zealand, all within a decade. The founder of the Dunedin Methodist Central Mission in 1890, William Ready, was himself the product of the London slums but was one of the lucky boys saved from its squalor and hopelessness by an act of charity. He became a minister of the Bible Christian Church (a smaller offshoot of Wesleyan Methodism) and was sent to New Zealand in 1887. When he came south in May 1890, charged to do similar work, he began in the way he believed was most appropriate – he stood on a soap box, sang a hymn, gathered a crowd, and invited them to worship the next day."

The Mission's kaupapa, centered around providing and creating support networks, is one of the many strengths of our Youth Transition Houses. Recently, a resident decided to convene a meeting with all their supports to develop a plan for addressing current issues they are facing. This gathering presented a valuable opportunity for them to visually see the size of their support network, with everyone in the same room discussing important matters. The presence of their supporters reinforced the interconnectedness and width of support, instilling confidence about the future.

Just like the roots of the kahikatea tree establish vital connections, these supports intricately weave the Mission into the fabric of the wider communities of Otago and Southland, connecting the Mission's kaupapa with others and fostering a symbiotic relationship that nurtures growth and vitality. More evidence of the Mission's network support can be seen at our Early Childhood Education (ECE) center, Little Citizens, where the families of the attending children are supported by our Taituarā a Hapori, facilitating agency and advocacy for those in need. Sustaining Tenancy clients are connected with budgeting services and offered physical assistance when required.

Community represents the interconnectedness that binds us together, and in times of adversity, it is through this connection that we find solace, support, and attainable solutions.

With faith we continue to create community, we will plant our seeds and invest in solid foundations, living in the embrace of others with wide, interconnected roots that allow us to cultivate resilience and thrive in the community we serve.

Economic Justice - Building a Methodist Response

Recently MCNZ President Peter wrote to our Prime Minister about the issue of economic justice and received a long

response from Hon. Carmel Sepuloni, Minister for Social Development and Employment, as the matters raised fell within her portfolio.

In her letter, Minister Sepuloni sets out what the Government has done and states that the welfare system may not be meeting the needs of all New Zealanders. She goes on to say that the Government is committed to overhauling the welfare system, provides a link to the progress they have achieved to date on the recommendations of the Welfare Expert Advisory Group[1] and acknowledged there is more work to be done.

Minister Sepuloni describes the Inland Revenue's research on how much tax high-wealth individuals pay as "an important basis for future discussions about tax policy."

Minister Sepuloni acknowledged in her letter that MSD and IRD treat debtors and debt differently. She advised that the Government is moving towards "a more unified, cross-agency approach to the way in which debts and debtors are treated." Some members of the Methodist Alliance Working Group campaigning to increase benefit levels and abatement thresholds attended the consultation on a proposed debt to government framework earlier this year.

This same Working Group has produced a resource for Parishes to facilitate robust discussions on the topics of income security, wealth distribution and debt to Government. The Working Group also partnered with ActionStation's Fairer Futures network, a collaboration of anti-poverty groups calling for Government to wipe debt to the Ministry of Social Development to lift the weight off families and whanau. Fairer Futures is also campaigning for liveable incomes in Aotearoa New Zealand with seven steps for a fairer future. The resource includes some of the stories from the Lifting the Weight Report to illustrate what life is actually like.

We hope to have the resource available for distribution at the August Synods, and we encourage everyone to use this resource to deepen your understandings of the issues. We hope the resource will also be useful in assisting you to frame questions to ask candidates in any meet the candidates meetings you hold.

We are open to hearing feedback, suggestions, and thoughts from across the connexion about what more Weteriana can do to help shift Aotearoa New Zealand to a more just economy and society where everyone can flourish.
